**1. **2. Warning:** As a participant in the above surf program, I recognise and acknowledge that there are certain risks of physical injury and I agree to assume the full risk of any injuries, including death, damages, or loss which I may sustain as a result of participating in any or all activities connected with or associated with such program. I have voluntarily read and understood this warning and accept and assume the inherent risks in participating in the Surfing program. I declare that I am medically and physically fit and able to participate in the Surfing program and I will immediately notify the Organisers of any change to my fitness and ability to participate.

**3. Instructions:** I will at all times comply with the instructions and safety procedures of the Organisers.

**4. Medical Treatment:** In case of accident or sickness I consent to emergency medical care provided by the Organisers and if required by ambulance or hospital personnel. I authorise such actions being taken by the Organisers and agree to meet all costs associated with such action.

**5.
